

**ORDINANCE NO. 184845**

\*Authorize a grant agreement with Outside In in an amount not to exceed \$65,000 to operate the Injection Drug Users Health Services Program. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Outside In operates an Injection Drug Users Health Services Program (IDU-HSP) whose objective is to decrease the number of new HIV and HEP C infections among injection drug users in the program, including the removal of used syringes from circulation.
2. The Syringe Exchange Program, one component of the IDU-HSP, specifically targets those who need sterile injection equipment, including syringes, bleach, water, and other safer injections supplies.
3. In January 2006, IDU HS added a treatment readiness service that includes a weekly group, individual counseling and treatment referral on demand.
4. The City Council has authorized \$65,000 in the FY2011-12 Special Appropriations Adopted Budget for the Injection Drug Users Health Services Program.
5. The City of Portland and Outside In now desire to enter into a grant agreement in a sum not to exceed \$65,000.

NOW, THEREFORE, the Council directs:

- a. That the Mayor and Auditor are authorized to execute a grant agreement in an amount not to exceed \$65,000 in one-time funds with Outside In -- substantially in conformance with the agreement attached as Exhibit A to the original of this ordinance.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the General Fund Special Appropriation when demand is presented and approved by the proper authority.

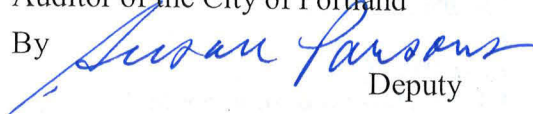

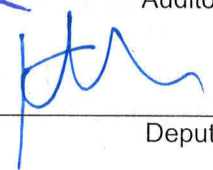
