ORDINANCE No. 184859

* Authorize application to the Oregon Department of Transportation, Transportation Safety Division for a grant in the amount of \$70,000 for the 2012 Multnomah County DUII Intensive Supervision Program (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Oregon Department of Transportation (ODOT) Transportation Safety Division (TSD) makes awards for direct law enforcement capability for court-based probation programs; and
- 2. The City of Portland, Oregon Police Bureau wishes to apply for ODOT Transportation Safety Division grant funding. Traffic Division sworn personnel will provide direct law enforcement capability to the court-based probation program by conducting warrant sweeps and checking for additional violations of the terms and conditions of the probation; and
- 3. ODOT will reimburse the City a maximum of \$70,000 for expenses incurred for sworn personnel overtime hours worked on the 2012 ODOT DUII Intensive Supervision Program (DISP) grant; and
- 4. Local match in the amount of \$210,003 will be provided by Traffic personnel straight-time expenses from FY 2011-12 and FY 2012-13 bureau program budget appropriations; and
- 5. The grant period is October 1, 2011, through September 30, 2012.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to make application to ODOT TSD for a grant in the amount of \$70,000 in a form substantially in accordance with the application attached as Exhibit A.
- b. The Mayor is authorized to provide such information and assurances as are required for the grant period.
- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists because a delay in proceeding with this application may result in not receiving funding. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
