

**ORDINANCE No. 184869**

\*Authorize a contract and provide for payment for Emergency Coordination Center project.  
(Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The design for the Emergency Coordination Center is complete and construction documents were prepared and have gone out to public bid. The Emergency Coordination Center includes construction of both a new building as well as the relocation of a section of SE Bush Street.
2. The cost to construct the new street and building for the Emergency Coordination Center is estimated to be \$11,000,000. The construction estimate is within the project budget.
3. The Emergency Coordination Center is designed to meet the LEED Gold certification as well as all other conditions of the City's "Green Building Policy" and the State of Oregon's 1.5% for Solar program.

NOW THEREFORE, the Council directs:

- a. The Mayor and Auditor are hereby authorized to enter into a contract with the lowest responsive and responsible bidder for the Emergency Coordination Center project.
- b. The Mayor and Auditor are hereby authorized to draw and deliver checks chargeable to the 2011-2012 budget when demand is presented and approved by the proper authorities.

SECTION 2. The Council declares that an emergency exists to avoid a delay in proceeding with the Contract; therefore, this ordinance shall be in full force and effect from and after its passage by Council.


