WHEREAS, changing POEM's name to the Portland Bureau of Emergency Management is consistent with the stature and authority of the bureau;

NOW, THEREFORE, BE IT RESOLVED: the City Council will adopt POEM's Strategic Plan 2011-2013; and

BE IT FURTHER RESOLVED, the City Council directs the City Attorney's Office to draft an ordinance that will change the Portland Office of Emergency Management to the Portland Bureau of Emergency Management.
