HEARINGS OFFICER'S ORDER

CITY OF PORTLAND, petitioner, vs. THERAPY LOUNGE, INC., respondent

FINDINGS OF FACT AND CONCLUSIONS OF LAW:

A hearing in this appeal case was heard on August 1, 2011. Mr. Duke Tufty ("Tufty"), attorney, appeared on behalf of Respondent Therapy Lounge, Inc, licensee and operator of Crown Room ("Respondent") and Ms. Ellen Osoinach, attorney, appeared on behalf of the City of Portland ("City"). Tufty and Osoinach agreed, on behalf of their clients, that Exhibit 61 shall be considered the operative "complaint" in this case; excepting violations occurring between February 19, 2011 and March 13, 2011 (bottom of page 1 of Exhibit 61) as well as violations occurring between April 9, 2011 and April 30, 2011 (top of page 2 of Exhibit 61) were dismissed by the City. Exhibits 1 through and including 61 were admitted into the evidentiary record at the August 1, 2011 hearing and Exhibits 62 through and including 72 are admitted by the Hearings Officer on his own motion. Witnesses Ridgely, Harris, Andonian, Gahan, Steinbronn, Hornstein and Marchetti testified at the August 1, 2011 hearing.

Exhibit 71, a transmittal letter from Marchetti, on behalf of the City, states that the "parties....have reached settlement...The parties request that a Final Order be issues incorporating the terms outlined in the attached document." The Hearings Officer reviewed Exhibit 72, a copy of the proposed Settlement Agreement. The Hearings Officer finds the terms and agreements contained in Exhibit 72 to be reasonable. The Hearings

Officer notes that one of the terms of Exhibit 72 is that the Hearings Officer retain jurisdiction until September 1, 2012. The Hearings Officer, noting that September 1, 2012 is a Saturday, finds it appropriate to retain jurisdiction until 4:30 p.m. on September 4, 2012.

The Hearings Officer finds it appropriate to incorporate the terms and agreements of Exhibit 72 into this Order (with the retention of jurisdiction date modification to September 4, 2012). The Hearings Officer finds that any violation of Exhibit 72 should be considered a violation of this Order and that paragraph 7 of Exhibit 72 shall apply.

ORDER AND DETERMINATION:

- 1. The Hearings Officer adopts Exhibit 72 as the Order in this case (excepting the Hearings Officer shall retain jurisdiction of this case until 4:30 p.m. on September 4, 2012). Neither party shall be considered the prevailing party.
- 2. If no request for additional hearing is received by the Hearings Office by 4:30 p.m. on September 4, 2012, this case shall be closed on September 5, 2012.
- 3. This order has been mailed to the parties on September 20, 2011, and shall become final and effective on October 4, 2011. Any objections to this order must be in writing and received by the Code Hearings Office prior to the effective date.
- 4. This order may be appealed to a court of competent jurisdiction pursuant to ORS 34.010 et seq.

Settlement Agreement

Effective Date: September 19th, 2011

Therapy Lounge, Inc., dba the Crown Room ("Crown Room"), and the City of Portland (the "City") agree to the following terms in full and complete settlement of City Code Violation Complaint, Case Hearing 2110005 (the "Complaint").

- Jurisdiction. The City and Crown Room agree that the Hearings Officer has jurisdiction over this
 matter until September 1, 2012. Crown Room acknowledges that a violation of the Portland City
 Code 14B.120 Time Place and Manner Regulation of establishments that serve and sell alcoholic
 beverages occurred at 204 NW 4th ave.
- 2. No Entry after 1:30AM. Crown Room agrees to not allow any new patrons to enter the premises after 1:30AM on Friday and Saturday nights and to stop alcohol service at 2:00AM.
- 3. Crown Room agrees to undertake all reasonable actions necessary and appropriate to prevent the occurrence of any offensive littering or disorderly conduct violations.
- 4. Alcohol Service. Crown Room agrees to:
 - a. Limit each patron to possessing no more than two containers of alcohol. Service staff must be able to interact verbally with each individual ordering an alcoholic beverage. This does not prohibit one patron from paying for an alcoholic beverage for another patron or transporting an alcoholic beverage to a table for another patron.
 - b. Not sell shots, double shots, or drop-shots. Shots are alcoholic beverages served in a shot glass and do not include alcoholic beverages served in snifters or rock glasses without ice, such as a Grand Marnier in a snifter or scotch in a rocks glass.
 - Limit the amount of alcohol in a container to no more than 16 ounces of malt beverage, 6 ounces of wine, or 2 ounces of distilled spirits.
 - d. Only serve bottles of wine or champagne to groups of two or more patrons.
- 5. Security. Crown Room agrees to:
 - a. Have a minimum of six (6) DPSST certified security staff at the Crown Room from 10:00PM to close on Friday and Saturday nights. On Friday and Saturday nights from 10:00PM to close, Crown Room agrees to:
 - i. Designate two persons* as entrance security leads who will monitor and control entrance to the establishment, enforce the dress code, and use a metal detector on individuals before allowing them into the establishment.
 - ii. Designate one person* as the side exit monitor whose primary duty is to monitor and control the side exit into the smoking area and exterior of the establishment. The side exit monitor will not allow an individual entry or

re-entry into the establishment through the side door. Individuals seeking re-entry must wait in line for entry through the front entrance.

- iii. Designate one person* as an alcohol monitor whose primary duty is to monitor the premises for intoxicated patrons.
 - *The actual individual performing these functions during the evening may vary as staff take breaks, or otherwise shift roles over the course of the evening.

ONI

- Have a minimum of two (2) DPSST certified security staff at Crown Room from 10:00PM to close on Tuesday, Wednesday, and Thursday evenings.
- 6. Entertainment. Crown Room agrees to:
 - a. Discontinue its "Massive" event.
- 7. <u>Violations</u>. During the time specified in section 1, the City may set a hearing with the Hearings Office to present evidence that this order has been violated. If the Hearings Officer determines that the order has been violated, the City and Crown Room agree that the appropriate remedy is a \$1,000 fine for each proven violation.
