## **ORDINANCE NO.** 184890

Authorize a Memorandum of Understanding between the Revenue Bureau and Worksystems, Inc. to implement the Youth Employment Credits authorized under PCC 7.02.880 (Ordinance)

The City of Portland ordains:

## Section 1. The Council finds:

- 1. The City Council passed Ordinance No 184716 on July 6, 2011, which established nonrefundable business license tax credits for youth employment for the 2011 and 2012 tax years.
- 2. PCC 7.02.882 requires that the City enter into an agreement or memorandum of understanding with a partner agency to act as the certifying agency for one of the youth credits established.
- 3. Worksystems, Inc. is willing and able to act as the certifying agency for both youth employment credits currently authorized for the 2011 and 2012 tax years under PCC 7.02.880.

## NOW, THEREFORE, the Council directs:

a. The Director of the Revenue Bureau is authorized and directed to execute on behalf of the City a Memorandum of Understanding with Worksystems, Inc. substantially similar to the document attached to this ordinance as Exhibit A.
