

ORDINANCE No. 184891

Authorize change in repayment term dates in Oregon Department of Environmental Quality Clean Water State Revolving Fund loan number R74171 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The mission of the Bureau of Environmental Services (BES) is to protect public health, water quality and the environment. This is accomplished both through traditional sewer system projects and non-traditional work such as revegetation.
2. The Oregon Department of Environmental Quality's State Revolving Loan Fund Program (SRF) offers loans for traditional and non-traditional water quality enhancement projects.
3. BES has entered into a loan agreement with DEQ (loan number R74171).
4. This ordinance changes the first repayment date of the loan.

NOW, THEREFORE, the council directs:


- a. The Commissioner of Public Affairs is authorized to change the repayment date of Oregon Department of Environmental Quality Clean Water State Revolving Fund loan number R74171.
- b. The Director of BES of the City of Portland is authorized to accept on behalf of the City of Portland any subsequent modifications by DEQ, provided such modifications do not increase the City of Portland's financial obligation or risk. Any modifications that increase the City of Portland's financial obligation or risk must be authorized by the Portland City Council.
