I. RECOMMENDATION

Pass ordinance to amend Oregon Department of Environmental Quality Clean Water State Revolving Fund loan number R74171 to change the repayment date of the first payment.

II. BACKGROUND

The Clean Water State Revolving Fund (CWSRF) loan program provides low-cost loans for the planning, design and construction of various water pollution control activities. Any public agency in Oregon is eligible for a CWSRF loan.

The City holds several of these low-interest loans. SRF loan number 74171 was used to fund revegetation projects.

III. FINANCIAL IMPACT

The change extends debt service payments by two years.

There are no legal issues as a result of this legislation.
