

**ORDINANCE No. 184892**

\* Accept and appropriate a grant in the amount of \$616,765 in federal Neighborhood Stabilization Program-3 funds from Oregon Housing and Community Services. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds

1. On behalf of the City of Portland, the Portland Housing Bureau submitted a proposal on May 20, 2011 in response to a Request for Proposals issued by Oregon Housing and Community Services (OHCS) for a federal Neighborhood Stabilization Program-3 (NSP-3) grant that OHCS administers; and
2. Oregon Housing and Community Services notified Portland Housing Bureau (PHB) that OHCS awarded PHB an NSP-3 grant in the amount of \$616,765; and

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from Oregon Housing and Community Services for the Neighborhood Stabilization Program-3 in the amount of \$616,765.
- b. The Fiscal Year 2011-2012 budget is hereby amended as follows:

GRANTS FUND

Fund - 217

Business Area - HC00

Bureau Program Expenses - \$616,765

- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.
- d. The Director of Portland Housing Bureau of the City of Portland is authorized to accept on behalf of the City of Portland any subsequent modifications by Oregon Housing and Community Services, Grant Agreement #1402, provided such modifications do not increase the City of Portland's financial obligation or risk. Any modifications that increase the City of Portland's financial obligation or risk must be authorized by the Portland City Council.

Section 2. The Council declares that an emergency exists because a delay would impede the ability of the Portland Housing Bureau to meet proposed federal and state benchmarks. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.
