

ORDINANCE No. 184893

*Authorize Use Agreement between Portland Parks & Recreation and Native American Youth and Family Center to define permitting roles for baseball fields and access rights at Whitaker Ponds Natural Area (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:


1. The City of Portland is the owner and/or manager of Whitaker Ponds Natural Area located in NE Portland, which, among other things, includes baseball fields.
2. The Native American Youth and Family Center (NAYA) owns the property at 5135 NE Columbia Blvd. adjacent to Whitaker Ponds Natural Area, which also includes several baseball fields.
3. Through permits issued by Portland Parks & Recreation (PP&R), Lakeside Little League (LLL) has been using the fields on the PP&R and NAYA (formerly Portland Public Schools) properties for practices and games for many years. NAYA is willing to continue to allow such use of its fields and issue permits to LLL for its use.
4. PP&R has long accessed a portion of the Whitaker Ponds site by way of a road over NAYA property. PP&R continues to need this access route, primarily for the purpose of maintaining the fields and natural area. This agreement grants such access.

NOW, THEREFORE, The Council Directs:

- a. The Director of Parks and Recreation is hereby authorized to execute a Use Agreement, substantially similar to the attached Exhibit A and as approved as to form by the City Attorney, with Native American Youth and Family Center.

Section 2. The Council declares that an emergency exists in order to avoid further delay in securing use of property needed for park and recreational purposes; therefore, this Ordinance shall be in force and effect from and after its passage by Council.
