My name is Katie Aldassy, I'm a 31 year old attorney and I live with my boyfriend in the King neighborhood in NE Portland. My house, which I own, is one and a half blocks from Miracles club. I have lived in the neighborhood for four years. The influence of Miracles on the streets near my home is only positive. The bubble around Miracles seems to keep crime to a minimum near my home, and helps create safety and community in a neighborhood that is really struggling with drugs and poverty. The club is no louder and creates no more activity on the streets than the three or four churches located within the same three block area. The club seems to me to belong where it is, as a positive resource in the community that serves an important purpose. It would be missed by it's patrons, of course, but also by individuals who've never visited it.

Please support Commissioner Saltzman's resolution. Miracles Club isn't the kind of place that would have an easy time fund-raising. Interests with financing would probably rather see a money-maker in that spot, which is why Miracles needs the city's help. You know that you would be doing the right thing in a neighborhood that needs the right thing done.
