ORDINANCE No. 184907

*Pay claim of Rich Grimes involving Portland Parks Bureau. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Mutual of Enumclaw Insurance Co., as auto insurer of Rich Grimes, has filed a subrogation claim against the City for reimbursement of medical payments it made to medical providers for treatment to Mr. Grimes for injuries suffered in an automobile collision involving the Parks Bureau on October 30, 2009.
2. The claim has been investigated by Risk Management Services. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of an adverse jury award, we feel it is prudent to compromise the claim at this time.
3. Risk Management Services recommends the subrogation claim of Mutual of Enumclaw Insurance Co. be compromised for the total sum of \$6,921.58; subject to the claimant providing the City with a release in a form to be approved by the City Attorney. Risk Management has previously advanced \$5,000 to Rich Grimes as settlement of his general damage claim. The total additional sum to be paid pursuant to this Ordinance is therefore \$6,921.58.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$6,921.58 made payable to Mutual of Enumclaw Insurance Co. Total claim settlement is \$11,921.58.
- b. Risk Management Services will execute a payment authorization in the amount set forth in sub-paragraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this claim; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.


