a) What impacts are anticipated in the community from this proposed Council item?

The proposed Council item will facilitate partnerships between the City and community organizations on Phase II of an acquisition and restoration project that protects, restores, and stewards a native oak woodland corridor in North Portland. The project entails significant neighborhood involvement and education. Project partners (Friends of Baltimore Woods, Columbia Land Trust, SOLV) will coordinate and implement stakeholder meetings to educate the neighborhood and general public about the Corridor's unique environmental values, conduct outreach to private property owners in the Corridor about existing and upcoming restoration work in the corridor, involve the general public in stewardship activities, and teach residents how to conduct environmentally sensitive landscaping in their yards.

Columbia Land Trust	The Columbia Land Trust is and will continue to coordinate land acquisition activities and assist with restoration management in the Baltimore Woods target area. They have been working in the Baltimore Woods Connectivity Corridor since 2008.
SOLV	SOLV will design and oversee restoration activities and volunteer event coordination in Baltimore Woods. They have been working in this area since 2010.
Depave	Depave will partner with BES, SOLV and the Friends of Baltimore Woods to "depave" 2 acres of unessential parking pavement on one of the targeted lots.
Friends of Baltimore Woods	Friends of Baltimore Woods (FOBW) formed in 1998 as a group of neighbors who set out to protect this mature canopy cover between North Baltimore and Catlin streets from increasing pressure of development in the neighborhood. FOBW recruits the volunteer base for work parties and long-term stewardship on the targeted lots.
Portland Parks and Recreation (PPR)	PPR will be the long-term manager for the majority of the targeted taxlots.

The Friends of Baltimore Woods (FOBW) has been an active participant in the development of this land acquisition and restoration effort. FOBW approached the City to become a partner in protecting the unique landscape and cultural features in the neighborhood. The City has been working in concert with the FOBW since 2008.

d) Who designed and implemented the public involvement related to this Council item?

A public involvement program has not yet been designed for this item, as negotiations are occurring with owners of the targeted lots and are, therefore, confidential. If acquisitions are successful, the Friends of Baltimore Woods will take the lead on outreach regarding the acquisition and restoration project. BES will be involved with any press releases or media events.

I. RECOMMENDATION

City Council should pass this ordinance to authorize Grant Agreements with Columbia Land Trust and SOLV to implement Phase II acquisition and restoration activities in the Baltimore Woods connectivity corridor, a target area Council has supported in previous ordinances.

II. BACKGROUND

The City of Portland was awarded a Metro Nature in Neighborhoods grant in the amount of \$158,000 on April 1, 2010. This grant was a joint effort between the Three Rivers Land Conservancy (now the Columbia Land Trust), the Friends of Baltimore Woods, SOLV, and BES. The purpose of the grant was to acquire and restore five key parcels (totaling one acre) within the Baltimore Woods Connectivity Corridor, with the landowner being the City of Portland.

The Grey to Green Land Acquisition Program identified Baltimore Woods as a priority target area for the City of Portland. Grey to Green is a five-year initiative to accelerate existing efforts to restore urban watershed health and protect rivers and streams. Baltimore Woods is a 30-acre woodland and greenspace running between the residential and industrial areas of the neighborhood near the Willamette River and St. Johns. The Corridor serves as a natural buffer, comprised of Oregon white oak and a mix of native and non-native plants. The Corridor also includes a section of proposed trail that would link Cathedral and Pier Parks as part of the proposed North Portland Willamette Greenway and 40-Mile Loop.

The City of Portland is currently partnering with Columbia Land Trust and SOLV through Intergovernmental Agreements (32000469 & 32000485) to implement acquisition and restoration activities on three properties (comprised of 5 parcels), known as Perrin/PMP, Thorp, and Bridgeview in the Baltimore Woods target area. Columbia Land Trust coordinates closing on of invasive plants, installation of native plants and bank stabilization.

This project expands the scope of work for Columbia Land Trust and SOLV to include an additional nine taxlots in the Corridor, which face various levels of development pressure and contain important historic oak woodland habitat types. The parcels have been targeted for natural area acquisition and restoration because they provide valuable wildlife and ecosystem benefits and represent one of the most intact undeveloped north-south corridors in North Portland. The undeveloped buffer also protects the nearby Willamette River by filtering stormwater from the Cathedral Park neighborhood, and offers a natural experience to future walkers and bikers of the Willamette Greenway.

Both Columbia Land Trust and SOLV are highly invested in the Baltimore Woods Connectivity Corridor through their work on the parcels noted above (Perrin/PMP, Thorp, and Bridgeview) as well as through neighborhood involvement/education throughout the Corridor. Columbia Land Trust will perform a variety of acquisition and restoration activities including coordinating land acquisition transactions and developing management plans for acquired parcels. SOLV will organize and lead community work parties to remove invasive species, install native vegetation, remove litter/debris, and stabilize banks.

III. FINANCIAL IMPACT

The Grant Agreements with Columbia Land Trust, SOLV, and Depave total \$25,000. Columbia Land Trust will invoice BES three times annually, each year, for a total of \$15,000. SOLV will invoice BES twice annually, each year, for a total of \$10,000. Funds are available in the Sewer Operating Fund, Bureau of Environmental Services, E08905.
