

ORDINANCE NO.

*Authorize application to U.S. Department of Housing and Urban Development for administration of the regional Homeless Management Information System and OTIS supportive housing programs (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The U.S. Department of Housing and Urban Development has made available a Notice of Funding Availability for annual renewals of two grants to administer the regional Homeless Management Information System and OTIS supportive housing program.
2. The Portland Housing Bureau is responding to the Notice of Funding Availability with two renewal applications for a total of \$513,060 in federal funds.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to make application to the U.S. Department of Housing and Urban Development for two renewal grants totaling \$513,060.
- b. The Mayor is authorized to provide such information and assurances as are reasonably required by the U.S. Department of Housing and Urban Development for the grant period.
- c. The Portland Housing Bureau, in collaboration with the OMF Grants Office, is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists because the grant must be submitted no later than October 28, 2011. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.
