## ORDINANCE No. 184951

\*Authorize the City Attorney Office to amend outside legal service agreement with Littler Mendelson PC (Ordinance; amend Contract No. 30001850)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The City requires the services of outside legal counsel because of workload considerations and a potential conflict of interest in an employee grievance matter related to Campbell v City of Portland et al.
- 2. The law firm of Littler Mendelson PC agreed to provide these services by contract no. 30001850.
- 3. Due to the nature of the matter it is necessary to amend the terms of the agreement, in a form closely resembling the attached draft amendment, increasing the amount of the contract.

NOW, THEREFORE, the Council directs:

- a. The City Attorney is authorized to amend outside legal service agreement 30001850 with Littler Mendelson PC, increasing the amount of the agreement by \$150,000 for a total amount not to exceed \$400,000.
- b. If applicable, the provisions of City Code Chapter 5.68 are waived.
- c. The Mayor and Auditor are authorized to draw and deliver warrants in payment of legal services provided under this ordinance.

Section 2. The Council declares that an emergency exists in order to continue to pay for legal services in a timely manner in the grievance matter related to <u>Campbell v City et al</u>; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
