ORDINANCE No. 184964

* Create two new Nonrepresented classifications of Environmental Compliance Manager and Environmental Investigations Manager and establish compensation rates for these classifications. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. In accordance with the policies established by the City Council and based on a classification and compensation review, the Bureau of Human Resources is creating a new Nonrepresented classification of Environmental Compliance Manager , effective August 26, 2010 and a new Nonrepresented classification of Environmental Investigations Manager, effective November 10, 2011.


