The U.S. Department of Justice (USDOJ) has notified the City of Portland that it will award a grant for the FY 2011 Bulletproof Vest Partnership/Body Armor Safety Initiative to the Police Bureau in the amount of \$4,414.52. The grant period is April 1, 2011, through August 31, 2013.

The USDOJ will reimburse the City a maximum of \$4,414.52 for expenses incurred for the purchase of 14 Threat Level III-A bulletproof vests for Police Bureau sworn personnel with the rank of officer through lieutenant (per Bureau Directive 1110.00 - Body Armor) whose vests are due for replacement during the next five years.
