* Authorize an agreement with Human Solutions, Inc. in the amount of \$105,000 for the provision of services in support of affordable housing. (Ordinance)

The City of Portland ordains:

SECTION 1. The Council finds that:

1. Portland Housing Bureau (PHB) is committed to fund organizations that provide a broad continuum of assistance and services to low income homeowners and renters.
2. On May 3, 2011 through Resolution No. 3052 the Gresham City Council authorized the award of \$25,000 of HOME funds to Human Solutions Inc. (HSI) for organizational operating support.
3. On September 8, 2011 PHB awarded HSI \$50,000 in HOME funds for organizational operating support and \$30,000 in Community Development Block Grant (CDBG) funds for rehabilitation of the Briarwood East project.
4. PHB will administer a CDBG/HOME Project Support Program agreement with HSI in the amount of \$105,000 for the fiscal year 2011-2012.

NOW, THEREFORE, the Council directs:

- a. The Bureau Director and the City Auditor are hereby authorized to enter into a formal agreement with HSI in accordance with the agreement attached as Exhibit A.
- b. The Mayor and City Auditor are hereby authorized to make payment chargeable to the FY 2010-11 Budget when demand is presented and approved by proper authority.

SECTION 2. The Council declares that an emergency exists because delay in funding would interrupt Human Solutions, Inc.'s ability to provide the services; therefore, this ordinance shall be in full force and effect from and after its passage by Council.


