

ORDINANCE No. 184985

Amend Intergovernmental Agreement with Metro to receive the local share component of the 2006 Natural Areas Bond Measure (Ordinance; amend Contract No. 52843)

The City of Portland ordains:

Section 1. The Council finds:

1. On April 11, 2007, the City Council approved Ordinance 180883 authorizing an IGA with Metro to accept local share funds from the 2006 voter-approved Natural Areas Bond Measure.
2. The local share IGA requires that local share funds be spent by March 31, 2012.
3. The IGA specifies that the deadline for spending the funds may be extended by mutual written consent of Metro and the Local Share Partner.
4. Metro and Portland Parks & Recreation staff have agreed to extend the period for one year to March 31, 2013.


NOW, THEREFORE, The Council Directs:

- a. The Director of Portland Parks & Recreation is authorized to execute an amendment in a form substantially similar to the attached and as approved as to form by the City Attorney.
- b. The Director of Parks and Recreation is authorized to sign future amendments to the IGA if needed to further extend the period allowed for spending local share funds.
