1) Legislation Title:

Authorize sole source acquisition and execution of a redevelopment agreement and related agreements (the "Redevelopment Agreement") with the Portland Winter Hawks, Inc. ("PWH") and Rip City Management, LLC, doing business as Portland Arena Management, successor-in-interest to Oregon Arena Corporation ("PAM"), for the renovation of Veterans Memorial Coliseum ("VMC"). (Ordinance)

2) Purpose of the Proposed Legislation:

This ordinance exempts the VMC renovation project from competitive bidding requirements of state law and City Code. The project will be executed based on a redevelopment agreement negotiated among the City, Portland Arena Management (PAM) and the Winter Hawks. PAM has exclusive operating rights to the VMC until 2023, has experience renovating spectator facilities, is willing to manage the Project without charging the project management fees, and is willing to take responsibility for construction of a portion of the renovation to avoid increased costs as a result of general contractor overhead and fees. For these reasons PAM's participation in the project should be authorized on a sole-source basis.

In addition, the award of the Redevelopment Agreement to PWH should be exempted from competition requirements of state law and City Code on a sole-source basis because PWH is the only user of VMC that is willing to commit significant private capital to the renovation costs (\$10 million).

SUBJECT: Veterans Memorial Coliseum

My office is filing two documents for the November 17th City Council agenda dealing with the renovation of Veterans Memorial Coliseum (VMC). The first item is a resolution and nonbinding term sheet for the project. PDC, OMF, the City Attorney and my office has negotiated this term sheet with our private partners on the project, Portland Arena Management (PAM) and the Portland Winter Hawks. The term sheet captures the parties' understandings on many of the critical business issues that must be addressed for this project to move forward.

The second item being filed is an ordinance authorizing the sole source acquisition and execution of a redevelopment agreement for the VMC with PAM and the Winter Hawks. As explained in the ordinance, PAM has exclusive operating rights to the VMC until 2023, has experience renovating spectator facilities, is willing to manage the Project without charging the project a management fees, and is willing to take responsibility for construction of a portion of the renovation to avoid increased costs as a result of general contractor overhead and fees.

In addition, the award of the Redevelopment Agreement to PWH should be exempted from competition requirements of state law and City Code on a sole-source basis because PWH is the only user of VMC that is willing to commit significant private capital to the renovation costs.

After so many years of uncertainty, I am very pleased that this project is moving ahead and this historic arena will be renovated and will continue to be a part of Portland's cultural infrastructure.

ORDINANCE NO.

Authorize sole source acquisition and execution of a redevelopment agreement and related agreements, the Redevelopment Agreement, with the Portland Winter Hawks, Inc. and Rip City Management, LLC, doing business as Portland Arena Management, successor-in-interest to Oregon Arena Corporation for the renovation of Veterans Memorial Coliseum (Ordinance)

The City of Portland ordains:

Section 1. Portland City Council ("Council") finds that:

- 1. The City plans to enter into a public/private partnership to design, finance, and construct renovations to VMC (the "Project") for the purpose of contributing to the revitalization of the Rose Quarter.
- 2. VMC is owned by the City and operated by PAM pursuant to that certain Memorial Coliseum Operating Agreement, dated as of April 23, 1993 (the "Operating Agreement"), between the City and PAM.
- 3. VMC currently serves as the primary venue for PWH, a user of VMC pursuant to a contract with PAM and the owner and operator of Portland's Western Hockey League franchise.
- 4. The City proposes to enter into the Redevelopment Agreement with PAM and PWH to, among other things, share the costs of the Project. The City also proposes to amend the Operating Agreement as may be necessary to facilitate financing for the Project or the negotiation of the Redevelopment Agreement.
- 5. The City Council is the Local Contract Review Board with authority to exempt certain goods and services contracts from the competitive bidding requirements of Oregon state law and City Code.
- 6. The award of the Redevelopment Agreement to PAM should be exempted from competition requirements of state law and City Code on a sole-source basis because PAM holds exclusive operating rights to VMC until 2023, has experience renovating spectator facilities, is willing to manage the Project without charging the City for Project management fees, and is amenable to managing the construction of portions of the renovations being done directly by vendors thereby avoiding general contractor overhead and fees. To the City's knowledge, no other entity exists that is willing to manage the Project without charge to the City or the Project.
- 7. In addition, the award of the Redevelopment Agreement to PWH should be exempted from competition requirements of state law and City Code on a sole-source basis because PWH is the only user of VMC that is willing to commit significant private capital to the renovation costs.
- 8. The Redevelopment Agreement will require compliance with the City's or PDC's workforce and business equity policies.

9. Attached as Exhibit A to this ordinance is the Proposed Transaction Terms (Renovation of Veterans Memorial Coliseum) for the Redevelopment Agreement.

NOW, THEREFORE, Council directs:

- a. Council adopts the findings set forth above.
- b. Based on the findings above, the Redevelopment Agreement and related agreements are exempt from competition as sole source contracts under state law and City Code.
