

ORDINANCE No. 185005

*Authorize an Agreement with Comcast of Illinois/Ohio/Oregon, LLC and Comcast of Oregon II, Inc. for Institutional Network Service (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. This Agreement is with Comcast of Illinois/Ohio/Oregon, LLC and Comcast of Oregon II, Inc. (Comcast) for the provision of services on the Institutional Network (I-Net) and the interconnection of the Integrated Regional Network Enterprise (IRNE) to the I-Net.
2. The I-Net, constructed pursuant to cable franchises issued by the City of Portland (City) and presently operated by Comcast entities, was interconnected to the City's IRNE network in 2002 pursuant to Ordinance No. 176579, passed by the Council on June 5, 2002, authorizing Agreement No. 51785 (now renumbered as Agreement No. 30000346) between AT&T Broadband of Ohio LLC and TCI Cablevision of Oregon Inc. (the I-Net/IRNE Interconnection Agreement) to provide regional broadband services options to local governments, schools and public agencies throughout Multnomah County. The I-Net/IRNE Interconnection Agreement is managed by the Communications Division of the City's Bureau of Technology Services.
3. The I-Net/IRNE Interconnection Agreement is for a period of five years from January 1, 2012 through December 31, 2016 with an extension not to exceed an additional five years.
4. The not-to-exceed value of this Agreement shall be \$7,500,000 for the initial five-year term, and \$12,500,000 for the five-year renewal term. The dollar increase between years five and ten are to address Comcast rate increases in accordance with the terms of the Agreement and to support additional I-Net customers from whom supporting revenues shall be collected by the City.
5. The City's Comcast cable franchises were passed by Council on November 16, 2011. The public interest will be served by authorizing this Agreement with Comcast substantially in accordance with Exhibit A attached for I-Net/IRNE Interconnection.

NOW, THEREFORE, the Council Directs:

- a. The Chief Procurement Officer is hereby authorized to enter into this Agreement with Comcast of Illinois/Ohio/Oregon, LLC and Comcast of Oregon II, Inc. substantially in accordance with the Agreement attached as Exhibit A for I-Net/IRNE Interconnection and approved as to form by the City Attorney.

Section 2. The Council declares that an emergency exists because there should be no disruption in the services provided by the I-Net/IRNE Interconnection to local governments, schools and public agencies throughout Multnomah County; therefore, this Ordinance shall be in full force and effect from and after its passage by Council.
