Accept report of General Fund Overhead Advisory Committee and adopt recommendations (Resolution)

WHEREAS, City Council included the following budget note as part of the FY 2011-12 Adopted Budget:

"Council directs the Office of Management and Finance to update the General Fund Overhead Model. Updates to the model may include adjustments to cost pools, bureau metrics, and allocation methodologies. A report to Council outlining the changes to the model will be delivered to Council during the FY 2011-12 Fall Budget Monitoring Process. Upon receipt of the report, Council may authorize General Fund target adjustments for FY 2012-13 as recommended in the report."

WHEREAS, the General Fund Overhead Advisory Committee, with the consultation of Financial Planning Division staff, met twice as a body to review model change options and impacts;

WHEREAS, in addition to the Committee reviews, Financial Planning Division staff met with the City's largest overhead receiving bureaus to review the appropriateness of the current cost allocation methodology;

WHEREAS, City Comprehensive Financial Management Policy 2.08 states, "The cost allocation system shall include a methodology that provides for the stability, predictability and equity of charges – in that order of priority. The primary metrics available to be used for allocating costs are the size of an agency's budget and the number of full-time equivalent employees.";

WHEREAS, the Committee recommends changes to the General Fund Overhead Model to achieve these goals;

NOW, THEREFORE, BE IT RESOLVED that the City of Portland hereby accepts the report of the General Fund Overhead Advisory Committee, as included in Exhibit A, and directs the Financial Planning Division to make the recommended changes to the General Fund Overhead Model and Current Appropriation Level Targets included therein, effective immediately and to be used in the FY 2012-13 budget development.
