## ORDINANCE No. 185012

Create the classifications of Arborist II, Arborist II, and Arborist IV and establish a compensation rate for those classifications and the classification of Arborist III. (Ordinance)

The City of Portland ordains:

## Section 1. The Council finds:

- 1. In accordance with the policies established by the City Council and based on a classification and compensation review, the Bureau of Human Resources is creating three new represented classifications effective January 5, 2012.
- 2. In accordance with the policies established by the City Council and based on a classification and compensation review, the Bureau of Human Resources is changing the salary rate of one classification effective January 5, 2012.
- 3. The business needs that these classifications are intended to meet cannot be fulfilled until the classifications and wage rates are established, however the wage rates for the classifications must be collectively bargained with District Council of Trade Unions (DCTU), Laborers' International Union, Local 483. Under Article 26.5.1 of the DCTU contract, the City may establish interim rates during bargaining.

## NOW, THEREFORE, the Council directs:

a. The following classifications are being created:

c. When the City and DCTU conclude necessary bargaining over the appropriate salary rates, the rates may be implemented with no further action upon signing of a Memorandum of Agreement between the Director of Human Resources and DCTU and approval as to form by the Office of the City Attorney.
