ORDINANCE No. 185036

Extend the date of the privileges for regular disabled parking permits (Ordinance; amend Code Section 16.20.640)

The City of Portland ordains:

Section 1. The Council finds:

- 1. On January 2, 2008, Portland City Council approved Ordinance No. 181507, which temporarily extended the privileges for regular disabled parking permits in the City of Portland meter districts until June 30, 2008. On June 11, 2008, Portland City Council approved Ordinance No. 181914, temporarily extending the privileges again until December 31, 2008. On November 19, 2008, Portland City Council approved Ordinance No. 182345, temporarily extending the privileges again until June 30, 2009. On June 24, 2009, Portland City Council approved Ordinance No. 182935, temporarily extending the privileges again until June 30, 2011. On June 1, 2011, Portland City Council approved Ordinance No. 184628, temporarily extending the privileges again until December 31, 2011.
- 2. On December 19, 2007, Portland City Council adopted Resolution No. 36562, which established the Disabled Parking Task Force to develop recommendations for Council on the implementation of Oregon State Senate Bill 716.
- 3. This Task Force submitted a Report to Council on June 3, 2009. Their work included the city requesting Multnomah County Court for increases in bail amounts for unlawful use, the city sponsoring SB 937, which requires medical certification for state placard renewal, and sending letters to the Oregon Medical Association, Oregon Academy of Family Physicians and Physicians for Social Responsibility stating their concerns regarding placard abuse and reminding their memberships of state placard requirements.

NOW, THEREFORE, the Council directs:

- a. Section 16.20.640, Disabled Parking Permit, is amended by changing the expiration date of subsection F. as follows:
 - F. Parking privileges for vehicle parking utilizing Section 16.20.640 will be extended under Senate Bill 716 Section 7 (3). All regulations within this Section will be granted and enforced; this Section will expire on December 31, 2011 December 31, 2012.
