Section 1. The Council finds:

1. In accordance with the policies established by the City Council and based on a classification and compensation review, the Bureau of Human Resources is changing the salary ranges of the Nonrepresented classifications Risk Manager and Risk Supervisor, effective October 7, 2010.


NOW, THEREFORE, the Council directs:
