

ORDINANCE No. 185066

*Revise Ordinance to include back pay owed to Thomas Gogas for the period of September 15, 2011 to November 18, 2011 (Ordinance; amend Ordinance No. 185000)

The City of Portland ordains:

Section 1. The Council finds:

1. The Council ratified a grievance settlement regarding wages and back pay via Ordinance No. 185000 on November 16, 2011.
2. Ordinance No. 185000 authorized payment of back wages in the amount of \$9,378.55 for the period of November 11, 2010 to September 14, 2011.
3. Ordinance No. 185000 did not take into account the amount of back pay owed to Mr. Gogas for the period of September 15, 2011 to November 18, 2011.
4. The City owes Gogas back pay in the amount of \$1,494.40 for the period of September 15, 2011 to November 18, 2011. This amount is subject to regular payroll deductions, tax withholdings and contributions.
5. Upon receipt of \$1,494.40 less payroll deductions, tax withholdings and contributions, Gogas will be fully compensated for all back pay owed for the period of September 15, 2011 to November 18, 2011.

NOW, THEREFORE, the Council directs:

- a. Ordinance No. 185000 attached hereto as Exhibit A is amended to include the additional amount of \$1,494.40 owed to Gogas for back pay for the period of September 15, 2011 to November 18, 2011.
- b. The Council hereby approves payment of the back pay to Gogas in the amount of \$1,494.40, less payroll deductions, tax withholdings and contributions.
- c. The Mayor and City Auditor are hereby authorized to pay for said back pay from the Water Bureau budget.

Section 2. The Council declares that an emergency exists in order that this compensation action may occur without delay; therefore, this ordinance shall be in full force and effect after its passage by the Council.




