ORDINANCE No. 185000

*Ratify a Letter of Agreement with Operating Engineers Local 701 and Thomas Gogas authorizing the settlement of a grievance regarding wages and back pay (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Thomas Gogas was employed by the Water Bureau as a Water Meter Technician II who asserted via the contractual grievance procedure that he was paid the incorrect wage rate when he began the Operating Engineer II Training Program on November 11, 2010.
- 2. Article 27.1 of the CBA provides that, "Wages shall be paid in accordance with the provisions of Schedule A attached hereto." Mr. Gogas was a Water Meter Technician II and paid \$27.88 per hour until November 10, 2010 as per Schedule A.
- 3. On November 11, 2010, Employee was appointed to the Operating Engineer I classification in order to participate in the Operating Engineering II Training Program which had yet to be approved. Mr. Gogas was paid at the Operating Engineer I entry wage rate of \$22.22 per hour per Schedule A.
- 4. On December 22, 2010, the Union filed a Level One grievance alleging that the City was paying Employee at the incorrect entry wage rate.
- 5. In July 2011, the City agreed to implement an official Operating Engineer II Training Program. Under the HRAR 9.03 the employee's salary shall be paid at his or her current wage rate until he or she completes the Training Plan. At such time the employee successfully finishes the Training Plan, the employee is eligible for promotion to Operating Engineer II and paid according the applicable wage rate.
- 6. The City shall reappoint Mr. Gogas to the Water Meter Technician II classification, effective November 11, 2010, as set out in the Operating Engineer II Training Program.
- 7. The City shall pay Mr. Gogas back wages for the period November 11, 2010 to September 14, 2011 in the amount of \$9,378.55. This amount is subject to regular payroll deductions, tax withholdings and contributions.
- 8. The City and Operating Engineers Local 701 have a mutual interest in settling this grievance.
