* Authorize a grant agreement with Impact NW to deliver the after-school science program for the Portland Children's Levy (Ordinance)

2) Purpose of the Proposed Legislation:

To allow the Children's Levy to substitute Impact NW as the grantee delivering the aka Science after-school program at local SUN schools. The grant was originally made to the Oregon Health Career Center (OHCC). The grant agreement is attached as Exhibit A. OHCC notified the Children's Levy in June 2011 that the agency would cease operations as of July 1, 2011. Impact NW worked with OHCC to transfer delivery of the program to Impact NW and Children's Levy staff approved the transition. The draft grant agreement with Impact NW is attached as Exhibit B. The Children's Levy is seeking council approval to enter into the grant agreement with Impact NW.


