Good Afternoon,

Advanced American Construction has submitted the attached GMP letter. The GMP total is \$31,552,700. The following is a breakdown of the Dam 2 Towers GMP.

- Dam 2 Towers (North Tower Access and Wetwell Improvements, South Tower Access Improvements, and Dam 2 Fiber Conduit and Guardrail installation) - \$26,630,270
- → Phase 1 Fish Flow Improvements (72"x54"x12" Tee, Flow Meter, Installed during South Tower Shutdown) \$ 450,602
- Phase 2 Fish Flow Improvements (Remaining Piping required to divert Fish Flows to the Bull Run River)
   \$4,471,829 (Phase 2 will only move forward if the PWB receives a variance)

We need to submit the GMP to Purchasing as soon as possible in order to complete the project within the construction schedule provided to FERC and required by the Habitat Conservation Plan.
