Requested Council Hearing Date: December 21, 2011

I. RECOMMENDATION

Adopt this ordinance to transfer ownership and maintenance of public sanitary sewer facilities to the Port of Portland.

II. BACKGROUND

In February 1991, City Council authorized an intergovernmental agreement between the Port of Portland (the "Port") and the City of Portland (the "City") for the transfer of Port-owned sewage facilities at the Portland International Airport to the City. In September 1999, the Port granted to the City a perpetual easement, and eventually transferred ownership and maintenance of said sanitary sewer facilities to the City. The Port realigned portions of the sanitary sewer lines and facilities during construction of the Headquarters Portland 2 Building Project, resulting in some lines being abandoned for future use by the City. The City and the Port desire to transfer ownership and maintenance for the realigned and/or abandoned sanitary sewer facilities back to the Port. The City is authorized to transfer said facilities and the Port is authorized to accept the transfer of said facilities.

III. FINANCIAL IMPACT

Not applicable. There are no financial impact, no payment or receipt of funds, associated with this transfer of sewer facilities.

IV. LEGAL ISSUES

There are no outstanding legal issues.

V. CONTROVERSIAL ISSUES

No issues have materialized and none are anticipated.

This transfer is consistent with the City Charter authority "to operate and maintain a sewage disposal or sewage purification system", and the Bureau's mission to serve "the community by protecting public health, water quality and the environment".

The proposed ordinance authorizes the transfer of ownership of sewer facilities from the City to the Port. The sewer facilities were originally owned and maintained by the Port. The sewer facilities are located on Port-owned property at Portland International Airport. No other property owners are involved or affected by the transfer.

The City and Port are undertaking this action by mutual agreement. No other governmental entities were involved, or have jurisdiction over the transaction.
