This agreement begins to implement portions of TriMet's safety audit and PBOT's pedestrian safety program, high crash corridor program, and pedestrian plan as well as the recent East Portland in Motion plan.

c) How did public involvement shape the outcome of this Council item?

Direct advocacy for these safety projects as well as safety reviews by TriMet and PBOT resulted in this partnership.


