## ORDINANCE No. 185111

Amend contract with KPFF for additional work and compensation for the South Airport Basin Phase IV Pump Station, Project No. E06790 (Ordinance; amend Contract No. 37735)

#### The City of Portland ordains:

#### Section 1. The Council finds:

- 1. The Bureau of Environmental Services (BES) has need of continuing professional engineering services provided by KPFF for the completion of design work and to provide services during construction for the South Airport Basin Phase IV Pump Station, Project No. E06790.
- 1. KPFF is providing professional engineering services under Contract No. 37735, effective on November 19, 2007, with an expiration date of November 18, 2012.
- 2. This Amendment No. 3 will authorize additional work in the amount of \$29,890 for a new not-to-exceed contract amount of \$127,669. Additional design services will address constructability issues. Services during construction will address building permit requirement, and provide required testing during construction.
- 3. The established cost of this contract amendment is \$29,890. Funds are available in the Sewer System Operating Fund, FY 2012 Budget, Bureau of Environmental Services, Project Number E06790.
- 4. M/W/ESB participation after the authorization of this contract amendment will be \$10,214, 8% of the total amended contract amount of \$127,669.

### NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Utilities is authorized to execute an amendment to Contract No. 37735 with KPFF for the purpose described in Section 1, in the amount of \$29,890.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
