Authorize a contract with the lowest responsible bidder for the Portsmouth Force Main Odor Control Facility
Project No. E08927 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Environmental Services (BES) has a need to construct the Portsmouth Force Main Odor Control Facility, Project No. E08927.
2. The level of confidence in the estimated cost for the construction of the Portsmouth Force Main Odor Control Facility is optimal.
3. The estimated cost is \$1,800,000. Funds are available in the Sewer System Operating Fund, FY 2012 Budget, Bureau of Environmental Services, Cost Center ESEN000020, WBS Element E08927.

NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs is authorized to execute a contract with the lowest responsible bidder for the purpose described in Section 1.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
