ORDINANCE No. 185117

Authorize a contract and provide payment for construction of the Digester Mixing Upgrade Project at the Columbia Boulevard Wastewater Treatment Plant. Project No. E08944 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Columbia Boulevard Wastewater Treatment Plant (CBWTP) treats the City's wastewater in accordance with State of Oregon Department of Environmental Quality (DEQ) issued NPDES permit requirements
2. Anaerobic digesters are an integral part of the wastewater treatment plant and serve to treat biosolids for land application. The Bureau of Environmental Services requires addition of mixing to the digesters to enhance the anaerobic digestion treatment process.
3. The established cost is \$6,800,000. The level of confidence is Optimal. Funds are available in the Sewer System Operating Fund, FY 2011-2012 Budget, Bureau of Environmental Services, WBS Element E08944.

NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs is authorized to execute a contract with the lowest responsible bidder for the purpose described in Section 1.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.


