

## ORDINANCE No. 185118

Amend contract with Jensen Maritime Consultants and increase by \$16,000 for additional scope of work for fireboat design and engineering (Ordinance; amend Contract No. 30002110)

The City of Portland ordains:

Section 1. The Council finds:

1. The City of Portland, through Portland Fire & Rescue (PF&R), entered into Contract No. 30002110, with Jensen Maritime Consultants (Jensen), on June 1, 2011, for the design and engineering of two (2) 50' aluminum fire boats.
2. Part of the scope of work requires Jensen to be the technical advisor for selection of the shipyard that will build the fireboats, and to answer technical questions during the actual construction.
3. The original contract amount was \$45,250, with an expiration date of May 31, 2013.
4. On November 2, 2011, Council passed Ordinance 184966, authorizing a competitive solicitation process for the construction of the fireboats designed by Jensen.
5. On November 9, 2011, PF&R held a mandatory pre-submittal meeting for potential vendors.
6. At that meeting several potential vendors suggested the possibility of using alternative designs and/or materials to meet the specific needs described in the specifications and general arrangements of the boats. PF&R agreed to consider some of the alternative ideas.
7. Once the shipyard begins construction of the fireboats it will be required to submit drawings, weight estimates, and other engineering documents to support and/or validate the use of alternative ideas.
8. PF&R requires the services of a maritime architect/engineer to review and evaluate the drawings, weight estimates and other engineering documents submitted by the shipyard to ensure they adequately meet PF&R's needs.
9. Jensen provided the initial design and engineering of the fireboats and has in-depth knowledge of PF&R's requirements and Jensen has the time available to provide the review and evaluation of drawings, weight estimates and other engineering documents provided by the shipyard.
10. Jensen is willing to provide up to 100 hours of engineering support to review and evaluate, and a sum not to exceed \$16,000.

11. The additional compensation under this Ordinance is 35% of the original compensation amount of \$45,250. The new not-to-exceed amount of the Contract is \$61,250.
  12. The funding for this contract amendment is included in the 2010 G.O. Bond for apparatus replacement.

NOW THEREFORE, the Council directs:

- a. The Commissioner in Charge is authorized to amend Contract No. 30002110 with Jensen Maritime Consultants for services in accordance with Amendment No. 1, attached hereto as Exhibit A.
- b. The Mayor and the Auditor are hereby authorized to draw and deliver checks payable to Jensen Maritime Consultants chargeable to Portland Fire & Rescue when demand is presented and approved by the proper authorities.
