TO THE COUNCIL:

The Chief Procurement Officer has advertised and received bids for Bid Number 113677 for the Ankeny Pump Station Upgrade project for the Bureau of Environmental Services, with a construction cost estimate of \$7,225,000.00. The Bureau of Environmental Services rated the level of confidence in the project estimate as Optimal.

Bids were opened on December 8, 2011, and ten (10) bids were received. The low bid of Stellar J. Corporation was deemed responsive to the requirements of the solicitation. It is recommended that the bid of Stellar J. Corporation be accepted at the lump sum quoted in their bid for a total estimated amount of \$6,283,657.00.

The Bureau of Environmental Services along with Procurement Services, identified Nineteen (18) Divisions of Work as potential M/W/ESB subcontracting opportunities for this project, resulting in \$2,384,728.00 awarded to subcontractors.

Stellar J Corporation has committed to working with the City of Portland to attain its MWESB participation aspirations on the Ankeny Pump Station Upgrade project, and has submitted a plan outlining additional good faith efforts they will engage in to increase participation. Since the bid opening, they have increased MWESB participation to 4.9% or \$117,700.00 of the estimated subcontracting dollars.

Stellar J. Corporation has a current City of Portland Business License and their EEO Certification is current through August 2, 2013. The company is located in Woodland, Washington, and is not a State Certified MWESB Contractor.

Stellar J. Corporation is in Full Compliance with the Equal Benefits Program.

Funds are available for this project under Owner Cost Center E07833.

It is further recommended that a Performance Bond and a Payment Bond each in the amount of 100% of the contract amount be furnished by the Contractor.

It is also recommended that a two (2) year Maintenance/Warranty Bond for 20% of the final contract amount be furnished by the Contractor before final payment is released.

The bid sureties of the remaining bidders should be returned immediately in compliance with Section 5.34.410D of the City Code.

#### RE: Ankeny Pump Station, Bid Number 113677: MWESB Plan

To whom it may concern:

Stellar J Corporation (SJC) is committed to working with the City of Portland (City) to attain its MWESB Participation aspirations on the Ankeny Pump Station project.

Even though SJC met and even exceeded the Good Faith Effort (GFE) specified in the contract documents and was identified by the Procurement Manager in the city's December 20, 2011 letter to be found as the lowest responsive and responsible bidder, SJC is committed to further that Good Faith Effort and the MWESB participation for the project.

SJC's Good faith effort solicitation was 164% of the minimum Firms required. SJC sent out requests to 141 MWESB firms for this project, and received quotes from 32 firms, of which we identified 4 MWESB firms for utilization. The GFE solicitation performed by SJC was well in excess of the 90 firms required under the contract documents.

Originally SJC had originally identified 4 MWESB firms for utilization with a total dollar value of \$30,846. SJC currently has increased this Utilization to 9 MWESB firms for a total of \$113,828, an increase of 125% and 370% respectively. The amount of firms being utilized is higher than any of the other bidders.

SJC's plan to further increase the MWESB participation on this project includes:

- 1. Working with the City to identify other MWESB firms to solicit. This includes divisions of work previously identified, additional work divisions, and additional MWESB firms.
  - SJC has already contacted your office and was provided other firms to solicit from your Contracting Compliance Specialist which we are actively performing in advance of the contract award.
- 2. Contact the firms we previously solicited, but did not receive a bid from and see if they are interested in bidding the project at this time.

- This will allow MWESB firms that may have not had time to bid the project previously to now provide bids.
- 3. Solicit additional firms in divisions that were previously solicited.
  - SJC will expand the MWESB GFE solicitation on Divisions of work that have additional firms available to be solicited. This will expand that pool of bidders and should result in additional MWESB participation.
- 4. Solicitations in other divisions that were not originally identified either by the City or SJC.
  - We are reviewing the project to identify other divisions of work that will provide additional MWESB opportunities. Divisions that we have identified already include Diving, Tile, Drywall, Pipe Insulation, and Traffic Control. All of these scopes will be solicited in full accordance with the good faith effort requirements.
- 5. Further solicit MWESB firms for the divisions of work SJC was intending to self perform. Including breaking down the work SJC was going to self perform.
  - Stellar J has already identified additional opportunities to increase MWESB participation in the project by subcontracting out items that we intended to self- perform, including: Traffic control (Approximate value \$50,000), Structural Steel Erection (Approximate value \$120,000), Glazing (Approximate value \$35,000), Survey (Approximate value \$10,000), and Concrete Installation (Approximate value \$120,000). All of these scopes will be solicited in full accordance with the good faith effort requirements.
  - In review of the Form 1 submitted by the 5 low bidders for this project, Stellar J afforded more opportunities for MWESB participation than any other firm. We listed only 6 DOW's as being self-performed, the second place bidder listed 8, and the third place bidder listed 7. The fourth place bidder did not submit their forms, and the fifth place bidder listed 14 DOW's as being self-performed. As stated above, SJC is actively soliciting MWESB's for these DOW's.

- 6. We have contacted all of our major Subcontractors/Suppliers and have asked them to re-evaluate their scopes to provide additional opportunities for MWESB participation at lower tiers and if so, to solicit and break this work out.
  - Specifics include: Our demolition contractor, Performance Contracting, plans to subcontract to a WBE, Apex Environmental, in the amount of \$1,500.00, for air quality monitoring. They have also identified two additional scopes that they intend to subcontract to MWESB firms: Demolition/Concrete Sawing and Equipment Rental. This will add an estimated \$35,000 in MWESB work.
  - Our electrician, Tice Electric, has identified items with an approximate value of \$435,000 value in opportunities for MWESB participation.
- 7. SJC would also like to meet with your office as you see fit to see what other components could be included in this plan to maximize its results.
- 8. SJC will continue to work diligently and aggressively to increase the GFE and MWESB utilization on the project. In prior City of Portland projects SJC has had good success in increasing MWESB utilization in past projects and intends to do the same herewith. For example, we added three MWESB subcontractors post award on the Columbia Blvd Digester Project for a total of \$446,000. This accounted for 2.8% of the total value of the project and 8.7% of the value of the work subcontracted out over what we had at bid time.

#### Additional Background:

We wanted to provide some background on this project's unique make-up that led to the MWESB participation percentage:

Of SJC's bid price of \$6,238,650.00, approximately 5.0 million was available for subcontracting and supply after allocation for site and home office overhead and markup. The electrical and instrumentation portion of this project was in excess of \$2.1 million, of which there were no qualified MWESB contractors available despite SJC actively soliciting them. Equipment supply (including the 4 pumps rated at 16 million gallons per day each) was \$760,000; material supply for the valves was \$900,000; and material supply for the piping was \$600,000. These four items represented \$4.4 million dollars of work of which there are not MWESB's available to SJC to subcontract too. This reduces the amount of the contract available for MWESB participation to

approximately \$640,000.00. SJC has increased participation of the available amount to almost 20% and we are working hard to increase this total.

As stated previously we are working with Tice Electric, to make additional opportunities for MWESB's available. They provided the following background information on their scope of work. Tice Electric (the same electrician was listed by all three low bidders) experienced similar issues in achieving MWESB participation: Of the \$2.1 million in electrical and instrumentation, approximately \$1,785,000 was available after allocation for site and home office overhead and mark-up. Of this, the lighting and electrical gear packages were approximately \$805,000, and the rest of the electrical materials were worth approximately \$320,000, and the Instrumentation package was approximately \$200,000. Labor costs make up the balance of the electrical package. We have been working with Tice to provide additional MWESB opportunities and they have now identified \$435,000 in opportunities that they are actively soliciting to MWESB firms.

We at Stellar J are committed to affording as many opportunities as possible to MWESB firms, and will continue to actively work toward increasing our participation on this and other projects with the City of Portland. An example is that on our City of Portland Columbia Blvd. Digester Project we added 3 MWESB contractors post bid for a total of \$446,000. Our track record shows that we have been successful in this endeavor in the past and we intend for it to continue.
