- 7. **BACKGROUND/ANALYSIS:** Ordinance Number 184066 adopted on August 18, 2010 authorized a contract and provided for payment for the construction of the Columbia Boulevard Wastewater Treatment Plant Lagoon Reconstruction Phase 2 Project No. E07145.
- 8. **FINANCIAL IMPACT:** The engineer's estimate for this project was \$5,900,000.00 ("high" level of confidence). The bid submitted by R&G Excavating, Inc. is for the total amount of \$7,640,150.00. Funds are available in the Bureau of Environmental Services' Sewer System Operating Fund, FY 2011-2012 Budget, WBS Element E07145.
