a) What impacts are anticipated in the community from this proposed Council item?

The anticipated impact of this legislation is that the Public Involvement Advisory Council (PIAC) will continue to have diverse membership that represents various segments of the community as well as various bureaus within government. This diverse group of members will continue to make useful recommendations on public involvement that will enhance the greater community's ability to interact with City government and have their voices heard and considered on the decisions that affect them.

b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?

PIAC members and the staff coordinator for the PIAC conducted extensive outreach to community groups to invite them to apply to serve as a member of the PIAC. Groups included neighborhood coalitions, diversity and civic leadership organizations, City bureaus, youth organizations, public involvement professionals, business associations, etc. Announcements were also posted broadly (e.g. on City's website, in citywide newsletters such as local chapter of International Association for Public Participation) in order to draw the attention of the general public. Phone calls were also made to key organizations that involved youth, elders and people with disabilities. One on one meetings were set up with any interested candidates.

c) How did public involvement shape the outcome of this Council item?

Members from the community were invited to apply to become a member of the PIAC, and were encouraged to invite others to apply. A selection committee comprised of City staff and community members fully considered all applications that were submitted. City Council members have the final say in who is appointed to the PIAC.

The PIAC Coordinating Committee and the PIAC staff person designed and implemented the public involvement process for this Council item.

7. BACKGROUND ANALYSIS

The Public Involvement Advisory Council (PIAC) was adopted by City Council on Feb. 27, 2008, Resolution No. 36582. The goal of the PIAC is to strengthen and institutionalize the City's commitment to public involvement through adopted principles, policies, and guidelines that assist City bureaus in creating consistent expectations and processes for public involvement activities.

The Public Involvement Advisory Council is a standing body accountable to City Council comprised of community members and City staff working collaboratively. The Public Involvement Advisory Council will develop and advocate for policy and best practices related to improving public involvement across all City of Portland bureaus.

The role of the PIAC is to:

- Review and refine past recommendations regarding citywide public involvement.
- Develop guidelines and policy recommendations for citywide public involvement, to be presented to City Council for approval.
- Provide support and advice to City Council and City bureaus with implementation of shared public involvement guidelines and best practices.

- Encourage ongoing collaboration between the community, City bureaus and City Council in the development of shared public involvement guidelines.

Below is a list of candidates being brought forward for appointment or reappointment with their organizational affiliations. 11 of the 12 members being brought forward for appointments to the PIAC are community members that were selected in a competitive process. Each candidate reflects a critical perspective from the larger Portland community. One of our new candidates for appointment is from the Portland Housing Bureau and is replacing a staff person that no longer works for the City.

Each of the three members being brought forward for re-appointment has served one full term and has opted to serve a second term. The PIAC Charter allows members to serve a maximum of two terms. The selection committee felt that each of these members has been an asset on the PIAC and that the City would benefit from their continued service as they would enhance PIAC's ability to complete its current goals and initiatives.

The PIAC actively works to maintain an inclusive and diverse group that includes perspectives from neighborhood organizations, people with disabilities, immigrants and refugees, ethnic minorities, elders, youth, public involvement consultants, and other perspectives. This broad cross-section of the community helps ensure that the recommendations the PIAC gives to City Council are strengthened by the many perspectives that helped develop them. We are pleased to bring forward this slate of candidates to serve on the PIAC.
