ORDINANCE No. 185126

*Accept two amendments to the FY 2009 Urban Areas Security Initiative Grant from the Oregon Military Department, Office of Emergency Management, Department of Homeland Security, for a combined net gain of \$163,158 for financial assistance to address the unique equipment, training, planning, exercise and operational needs of large urban areas. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds

- 1. The City of Portland, in cooperation with the Portland Urban Area regional partners, was awarded a grant from the Department of Homeland Security for financial assistance to address the unique equipment, training, planning, exercise and operational needs of large urban areas.
- 2. On December 16th, 2009, Council passed Ordinance No 183409 accepting Urban Areas Security Initiative (UASI) Grant Program award number 09-170 for \$ 6,581,436.
- 3. The Department of Homeland Security is providing additional financial assistance to the Portland Urban Area through grant 09-170 in the amount of \$163,158. Amendment No 1 adjusted the total award to \$6,774,636. Amendment No 2 adjusted the total award to \$6,744,594.
- 4. Funds will be used to secure the purchase of enclosed trailers to store miscellaneous traffic management control devices. These trailers will be placed into strategic locations identified as critical high impact, or high volume of incident trouble spots using historical data. By placing the trailers at various locations, first responders will have immediate access to equipment needed to detour traffic around or thru the immediate incident.
- 5. The City of Portland Bureau of Emergency Management will administer the Grant for the region.
- 6. There is no financial match requirement for this Grant.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland an amendment to UASI Grant Program award number 09-170 from the Department of Homeland Security for \$163,158.
- b. The FY 2011/2012 budget is hereby amended as follows:

<u>GRANTS FUND</u> Fund - 217 Business Area – EM00 Bureau Program Expenses – \$163,158

- c. The Office of Management & Finance Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.
- d. The Director of the Portland Bureau of Emergency Management is authorized to accept on behalf of the City of Portland any subsequent modifications by the Department of Homeland Security for UASI Grant Program award number 09-170, provided such modifications do not increase the City of Portland's financial obligation or risk. Any modifications that increase the City of Portland's financial obligation or risk must be authorized by the Portland City Council.

Section 2. The Council declares that an emergency exists so as to maximize the grant award period of performance. Therefore, this Ordinance shall be in full force and effect from and after its passage by Council.
