ORDINANCE No. 185129

Authorize a contract and provide payment for construction of the Secondary Process Improvements at the Columbia Boulevard Wastewater Treatment Plant, Project No. E08909 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Columbia Boulevard Wastewater Treatment Plant (CBWTP) treats the City's wastewater in accordance with Oregon Department of Quality (DEQ) discharge permit requirements.
- 2. The Bureau of Environmental Services (BES) has a need to improve the secondary treatment system at the Columbia Boulevard Wastewater Treatment Plant (CBWTP).
- 3. The secondary treatment system at the Columbia Boulevard Wastewater Treatment Plant provides biological treatment for the wastewater through the plant. The current plant discharge permit requires minimum secondary biological treatment of 100 million gallons per day (mgd). In 2014, this minimum requirement will be increased to 110 mgd. Improvements to the secondary treatment system are needed to increase capacity to meet new permit requirements.
- 4. The last major improvements to the secondary treatment system were completed in 1994. Improvements are needed to update, and automate, the monitoring and control systems to handle rapid flow changes from the recently completed East Side Combined Sewer Overflow program.
- 5. The estimated cost is \$9,100,000. The level of confidence in the cost estimate is optimal. Funds are available in the Sewer System Operating Fund, FY 2012 Budget, Bureau of Environmental Services, WBS E08909.C60.

NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs is authorized to execute a contract with the lowest responsible bidder for the purpose described in Section 1.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
