

I. RECOMMENDATION

Authorize a contract and provide for payment for the construction of the SE 2nd and 3rd Ave. Sewer Replacement and SE 3rd and Alder Rehabilitation Project, BES Job No. E08847 (Ordinance)

II. BACKGROUND

During the routine TV inspection of the sewers on SE 2nd Ave. and SE 3rd Ave., some major deficiencies were found. These include numerous cracks, broken joints, sags and partially collapsed pipe. The sewer main on SE 2nd Ave. is 10" in diameter and built in 1907. The sewer main on SE 3rd Ave. is 8" in diameter and built in 1910. The total length of pipe to be replaced is approximately 760 feet.

Also, the intersection at SE 3rd and Alder needs to be rehabilitated due to the construction work of the East Side CSO project in the last couple of years.

This project will replace the existing mainline sewer by the open trench or Pilot Tube Microtunneling method in a new alignment parallel to the existing sewers. Manholes and service laterals will also be replaced. This project will also rehabilitate the intersection at SE 3rd and Alder by constructing new pavement, curb, sidewalk, driveway, inlet and inlet leads.
