## REPORT TO COUNCIL

April 21, 2010

Accept contract with Civil Works NW, Inc. for SW Cardinell Drive Water Work as complete and make final payment (Report; Contract No. 30000384)

On March 16, 2009, the City entered into Contract No. 30000384 with Civil Works NW, Inc. for the construction of the SW Cardinell Drive Water Work Project for an estimated amount of \$291,210. Upon beginning excavation for the water installation, it was determined by the Bureau of Environmental Services (BES) and Portland Water Bureau (PWB) engineers that the circa 1920 sewer line had failed, was leaking, and needed to be replaced. That change added approximately 1,200' of 16" sewer pipe to the original scope. Following the trenching of both the water and sewer lines in the narrow street, a full curb to curb street reconstruction was also necessary. The final cost of the project is \$738,976.96 and includes \$496,380 for change orders 1 and 2. All work on the contract was completed satisfactorily on December 12, 2009. Final Progress Payment to be made in the amount of \$2,455.53 is required.
