

ORDINANCE No. 185141

*Amend contract with Resolutions Northwest in the amount of \$3,675 to provide additional mediation and consultant services for Neighborhood Emergency Teams Program (Ordinance; amend Contract No. 30002352)

The City of Portland ordains:

Section 1. The Council finds:

1. On October 7, 2011 a contract was entered into between the City of Portland (City) and Resolutions Northwest to provide mediation and consultant services for the Neighborhood Emergency Teams (NET) Program.
2. The original Contract amount was \$5,000 with an expiration date of February 29, 2012.
3. Additional consultant services are required.
4. The Bureau of Emergency Management recommends that Contract No. 30002352 with Resolutions Northwest be amended to increase the compensation by \$3,675 and extend the expiration date to March 30, 2012.
5. The additional compensation under this Ordinance is \$3,675, which is 73.5% of the original compensation amount of \$5,000. The new not-to-exceed amount of the Contract is \$8,675.

NOW THEREFORE, the Council Directs:

- a. The Mayor is authorized to amend Contract No. 30002352 with Resolutions Northwest for services substantially in accordance with the amendment attached hereto as Exhibit A.
- b. The Mayor and the Auditor are hereby authorized to draw and deliver checks payable to Resolutions Northwest chargeable to the Bureau of Emergency Management when demand is presented and approved by the proper authorities.


