

ORDINANCE NO. 185170

* Authorize subrecipient contracts with Cascade AIDS Project and Worksystems, Inc. totaling \$1,253,400 to provide housing assistance, supportive services, and comprehensive planning and coordination of local resources to meet housing and service needs for people living with HIV/AIDS (Ordinance)

The City of Portland ordains:

SECTION 1. The Council finds that:

1. The City of Portland passed Ordinance No 184983 to accept and appropriate a \$1,365,900 Housing Opportunities for Persons With AIDS (HOPWA) grant from the U.S. Department of Housing and Urban Development (HUD) for housing assistance, supportive services, and coordination of local resources to meet housing and service needs for people living with HIV/AIDS (PLWHA).
2. Worksystems, Inc. (WSI) serves as the Workforce Investment Board in Multnomah and Washington Counties in Oregon and coordinates a regional workforce system that supports both individual prosperity and business competitiveness. Cascade AIDS Project (CAP) is the oldest and largest provider of housing and services to PLWHA in Oregon and SW Washington. WSI and CAP were proposed as project sponsors in the application for the awarded HUD grant, and must deliver services as proposed in that application in order for the City of Portland to meet the conditions of the awarded HUD grant.
3. The above stated programs and services meet the goals and objectives of the Portland Housing Bureau (PHB).
4. Total funding in the amount of \$1,108,950 in HUD funds will be allocated to a three-year contract with CAP. Total funding in the amount of \$144,450 in HUD funds will be allocated to a three-year contract with WSI. These funds will be allocated through appropriation to PHB in fiscal years 2011-12, 2012-13, 2013-14, and 2014-15. Total contract amounts are subject to such appropriations in each fiscal year.

NOW, THEREFORE, the Council directs:

- a. The Director of Portland Housing Bureau is hereby authorized to enter into agreements with CAP and WSI in a form substantially in accordance with the agreements attached hereto as Exhibits A and B.
- b. The Mayor and City Auditor are hereby authorized to make payment chargeable to each Portland Housing Bureau fiscal year budget when demand is presented and approved by the proper authority.

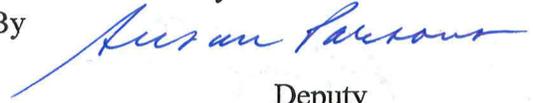
