ORDINANCE No. 185177

*Authorize a contract with Merina & Company, LLP for a total not to exceed amount of \$150,000 to audit, analyze and report on Detail Cost Reports from franchised grarge and recycling companies (Ordinance; Contract No. 30002508)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The City of Portland Bureau of Planning and Sustainability (BPS) administers regulations for garbage and recycling collection in the city, and residential collection is currently performed by 19 franchised residential garbage and recycling hauling companies.
- 2. The Portland City Council sets the rates charged for residential services each year based on information that BPS collects from different contractors selected to review Detail Cost Reports (DCR) from the franchised garbage and recycling companies; to forecast recycling markets; to analyze container contents; and to maintain an economic model that develops cost-of-service rates from the information provided by the other contractors.
- 3. BPS advertised a request for auditing services of DCRs under BPS RFP 022, "Residential Solid Waste & Recycling Rate Review Service" and received two responsive proposals. A selection committee reviewed and scored the proposals in accordance with PCC 5.68 and selected Merina & Company LLP.
- 4. The City desires to enter into a PTE contract with Merina & Company LLP with a not-to-exceed contract amount of \$150,000, for a period of five years, to audit and report on DCRs from a sample of Portland's garbage and recycling companies.
- 5. Merina & Company LLP is certified with the U.S. Small Business Administration as a Women-Owned Business and has applied for certification as a Woman-Owned Business Enterprise in Oregon.
- 6. Sufficient funding resides in the appropriated budget for the Bureau of Planning and Sustainability beginning in FY 2011-2012.

NOW, THEREFORE, the Council directs:

- a. The Chief Procurement Officer is authorized to enter into a contract with Merina & Company LLP for services in accordance with the contract attached hereto as Exhibit A.
- b. The Mayor and Auditor hereby are authorized to draw and deliver checks chargeable to the FY 2011-2012 budget for Bureau of Planning and Sustainability when demand is presented and approved by the proper authorities.

Section 2. The Council declares that an emergency exists due to the need for work to proceed in a rate-setting process depending on multiple different contracts. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.
