

## **Notice of Consolidated Plan and Fair Housing Plan Comment Period and Public Hearings**

The FY 2011-2016 Consolidated Plan and FY 2012-2013 Action Plans for Multnomah County, the City of Portland, and the City of Gresham describe and prioritize current housing and community development needs, establish strategies and set five-year goals to address those needs, and itemize how approximately \$11 to \$19 million dollars in CDBG, HOME and other federal resources will be invested during FY 2012-13, the first year of the new Consolidated Plan. The Consolidated Plan includes a Fair Housing Plan that describes fair housing within Multnomah County, and establishes strategies and sets goals for the jurisdictions to affirmatively further fair housing. Before making any changes to the Consolidated Plan through the One Year Action Plan, the jurisdictions want to give local residents and other stakeholders the opportunity to present comments and views.
