ORDINANCE No. 185211

*Authorize an Intergovernmental Agreement with the Oregon Department of Transportation for the Right-of-Way Services Agreement for the 102nd Avenue: NE Glisan St – SE Washington St Phase II. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Gateway Regional Center Plan prepared in 1999 identified improvements to 102nd Ave as a key element in a package of transportation improvements for the Gateway Regional Center.
- 2. The Gateway Urban Renewal Advisory Committee in cooperation with the Portland Bureau of Transportation applied for and received federal funds to conduct preliminary engineering for the first phase of the NE 102nd Ave. Improvement Project. Phase I has been completed.
- 3. On January 12, 2011, Council approved Ordinance No. 184371 that authorized a grant funding that covered the total anticipated cost for engineering and construction for phase II of the project, estimated at approximately \$2,445,563.00. This Intergovernmental Agreement is to allow the City of Portland to do the right-of-way phase of the project.

NOW, THEREFORE, the Council directs:

a. The Mayor and the Auditor are hereby authorized to enter into an Intergovernmental Agreement with the Oregon Department of Transportation for the Right-of-Way Services Agreement for the 102nd Avenue: NE Glisan St – SE Washington St Phase II in a form substantially in accordance with the attached exhibit for this purpose.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
