

ORDINANCE NO. 185218

* Authorize Intergovernmental Agreement with City of Gresham for the production of the annual Action Plan FY 2012-2013 updates and other plans and performance reports as requested of the Consortium by Housing and Urban Development and to receive payment (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The U.S. Department of Housing and Urban Development (HUD) requires entitlement jurisdictions to submit, a five-year Consolidated Plan, one-year Action Plans and an Analysis of Impediments to Fair Housing report.
2. The City of Portland (City) is designated the coordinator of the preparation and amendment of the Consortium's multi-year Consolidated Plans, annual Action Plans, Analysis of Impediments to Fair Housing, and Citizen Participation Plan. Multnomah County (County) and City of Gresham (Gresham) compensate the City for this service.
3. Gresham again desires to enter into agreements with the City, for the Action Plan FY 2012-2013, updates and other plans and performance reports as requested of the Consortium by HUD.


NOW THEREFORE, The Council directs:

- a. The Bureau Director and City Auditor are hereby authorized to enter into an intergovernmental agreement with Gresham, substantially in accordance with the agreement attached as Exhibits A respectfully.
- b. The Mayor and City Auditor are hereby authorized to receive payment from Gresham in the amount of \$10,000.

Section 2. The Council declares that an emergency exists so that there will be no delay in the delivery of services; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
