## **ORDINANCE NO.** 185218

\* Authorize Intergovernmental Agreement with City of Gresham for the production of the annual Action Plan FY 2012-2013 updates and other plans and performance reports as requested of the Consortium by Housing and Urban Development and to receive payment (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The U.S. Department of Housing and Urban Development (HUD) requires entitlement jurisdictions to submit, a five-year Consolidated Plan, one-year Action Plans and an Analysis of Impediments to Fair Housing report.
- 2. The City of Portland (City) is designated the coordinator of the preparation and amendment of the Consortium's multi-year Consolidated Plans, annual Action Plans, Analysis of Impediments to Fair Housing, and Citizen Participation Plan. Multnomah County (County) and City of Gresham (Gresham) compensate the City for this service.
- 3. Gresham again desires to enter into agreements with the City, for the Action Plan FY 2012-2013, updates and other plans and performance reports as requested of the Consortium by HUD.

NOW THEREFORE, The Council directs:

- a. The Bureau Director and City Auditor are hereby authorized to enter into an intergovernmental agreement with Gresham, substantially in accordance with the agreement attached as Exhibits A respectfully.
- b. The Mayor and City Auditor are hereby authorized to receive payment from Gresham in the amount of \$10,000.

Section 2. The Council declares that an emergency exists so that there will be no delay in the delivery of services; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
