

**ORDINANCE No. 185222**

\* Extend contract with Daniel Rossos for one year and increase by \$58,500 for additional National Fire Protection Association representative services (Ordinance; amend Contract No. 30000760)

The City of Portland ordains:

Section 1. The Council finds:

1. The City of Portland, through Portland Fire & Rescue (PF&R), entered into Contract No. 30000760, with Daniel Rossos (Rossos), on August 1, 2009.
2. The original contract amount was \$96,464, with an expiration date of July 31, 2011.
3. Amendment No. 1, dated October 8, 2010, provided for additional national committee meetings, and increased the compensation by \$24,116. The new not-to-exceed contract amount was increased to \$120,580.
4. Amendment No. 2, authorized by Ordinance No. 184784, dated August 3, 2011, provided for additional national meetings, and increased the compensation by \$32,154.64. The new not-to-exceed contract amount was increased to \$152,734.64.
5. In order for PF&R to maintain its principal membership on the NFPA committees, it must have someone designated as alternate members and allow adequate training time so the alternate members may prove themselves to the NFPA committees.
6. The NFPA will vote whether or not to accept the two alternate members nominated by PF&R in its March meeting.
7. During the training time the NFPA expects Mr. Rossos to be actively participating in ongoing committee work and supervising the work of the alternate members.
8. Therefore additional national committee meetings are required. PF&R recommends that Contract No. 30000760 with Daniel Rossos be amended to increase the compensation by up to \$58,500 and extend the expiration date to March 31, 2013.
9. The additional compensation under this Ordinance, along with previously added compensation, comes to \$114,770.64, which is 119% of the original compensation amount of \$96,464. The new not-to-exceed amount of the Contract is \$211,234.64.
10. The funding for this contract amendment is included in the PF&R FY 2012-13 requested budget.

NOW THEREFORE, the Council directs:

- a. The Commissioner in Charge is authorized to amend Contract No. 30000760 with Daniel Rossos for services in accordance with Amendment No. 3, attached hereto as Exhibit A.

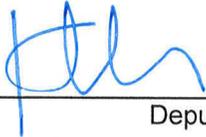
